Column C-Enter the tax paid each quarter to City of Corbin. DO NOT INCLUDE PENALTY AND INTEREST. Total Columns A, B, and C. Enter the total tax withheld per the listing or the City of Corbin (Knox County) Withheld per the W2's on line 1. If for some reason an employer paid the tax but did not withhold the tax, add that amount and enter on line 2. Add Lines 1 and 2 and enter total on Line 3.
